Many people are unaware of the high cost that irresponsible behavior could bring upon them. Not knowing the law will not get you off the hook either! The following was taken from the State of Wisconsin Revised Uniform Deposit and Bail Schedule. For detailed explanations or questions, contact your local DNR office.

| Operate ATV without valid registration | \$186.00 |
| Give permission to operate without valid registration | \$186.00 |
| Operate ATV on ATV trail without trail pass | \$154.25 |
| Operating in a careless manner | \$186.00 |
| Operate on private property of another without consent | \$249.00 |
| Operate on Indian lands without consent | \$160.50 |
| Transport loaded or uncased firearm or a strung or uncased bow | \$198.00 |
| Drive or pursue any animal | \$249.00 |
| Operate within 150 feet of a dwelling at a speed exceeding 10 mph | \$160.80 |
| Operate on frozen surface of public waters within 100 ft. of a person or fishing shanty over 10 mph | \$173.40 |
| Operate without headgear | \$135.60 |
| Illegal operation on or in the vicinity of highways | \$186.00 |
| Operate while intoxicated (first offense) | \$438.00 |
| Operate ATV while intoxicated with a passenger under the age of 16 (1st offense) | \$753.00 |
| Absolute sobriety under age 19 | \$154.50 |
| Refuse to take intoxicated ATV test (first offense) | \$438.00 |
| Operate an ATV without valid safety certificate | \$148.20 |
| ATV equipment violations | \$160.80 |
| Operate, sell, rent or manufacture ATV exceeding the 96 decibel noise limit | \$160.80 |
| Failure to report accident | \$173.40 |
| Interfere with sign and standards | \$312.00 |
| Failure to stop for Law Enforcement Officer | \$425.00 |
